

## TERMS OF USE

### Please read carefully

By accessing [www.bestofficespace.lu](http://www.bestofficespace.lu) ("Site") you confirm that you are a business user over the age of 18 years and permitted to use this Site, and you agree to be bound by all of the following terms and conditions of use ("Terms").
